Guidelines for Awarding Points in Research Activities

1. The Research score for research papers would be augmented as follows: Peer-Reviewed or UGC-listed Journals (Impact factor to be determined as per Thomson Reuter's list):
 - (i) Paper in refereed journals without impact factor - 5 Points
 - (ii) Paper with an impact factor of less than 1 - 10 Points
 - (iii) Paper with impact factor between 1 and 2 - 15 Points
 - (iv) Paper with impact factor between 2 and 5 - 20 Points
 - (v) Paper with impact factor between 5 and 10 - 25 Points
 - (vi) Paper with impact factor >10 - 30 Points

For Two authors: 70% of the total value of publication for each author. For more than two authors: 70% of the total value of publication for the First/Principal/Corresponding author and 30% of the total value of publication for each of the joint authors.

2. Joint Projects: The Principal Investigator and Co-investigator would get 50% each.
3. The paper presented is part of an edited book or proceeding then it can be claimed only once.
4. For joint supervision of research students, the formula shall be 70% of the total score for the Supervisor and Co-supervisor. The supervisor and Co-supervisor, both shall get 7 marks each.
5. For the purpose of calculating the research score of the teacher, the combined research score from the categories of 4(b). Policy Document and 5. Invited lectures/Resource Person/Paper presentations shall have an upper capping of thirty per cent of the total research score of the teacher concerned.
6. The assignments for the university and department will be assessed by HoD and DoS and award points based on the performance/outcome etc.
7. Discipline, Vision, Sincerity, Integrity, Punctuality, Attitude, Mutual Respect, Dedication, and Perception will be evaluated on each aspect. DoSs and the Vice Chancellor will adopt various mechanisms to collect the information to evaluate the faculty.
